#### New Delhi, the 19th December, 2012

G.S.R. 925(E)—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment to the posts of Principal, Professor, Associate Professor, Assistant Professor, Assistant Professor in Applied Sciences and Senior Librarian in Chandigarh College of Engineering and Technology, Chandigarh namely:-

- Short title and commencement. (1) These rules may be called the Chandigarh College of Engineering and Technology, Chandigarh Administration, Professor, Associate Professor, Assistant Professor, Assistant Professor in Applied Sciences and Senior Librarian (Group 'A' post) Recruitment Rules, 2012.
  - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. These rules shall apply to the posts specified in column (1) of the Schedule annexed to these rules.
- 3. Number of posts, classification and payband and grade pay or pay scale. The number of post, its classification and payband and grade pay or pay scale attached thereto shall be as specified in columns (2) to (4) of the said Schedule.
- 4. Method of recruitment, age-limit, qualifications etc.- The method of recruitment, age-limit, qualifications and other matters relating to the said post shall be as specified in columns (5) to (13) of the Schedule aforesaid.
- 5. Disqualification.-No person,-
- (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted marriage with any person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 6. Power to relax.- Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission relax any of the provisions of these rules with respect to any class or category of persons.
- 7. Saving.- Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, ex-Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Standard Terms and Conditions of the Government employees on deputation with Chandigarh Administration- Clarification regarding

Sir/Madam

In continuation of this Administration's letter No. 28/16/94-IH(7)-2025/4045 dated 25.03.2025 (copy enclosed), I am directed to state that provisions of Para 3(ii), 3(iii) & 3(iv) of the letter dated 25.03.2025 ibid are modified/ clarified as under:-

Para 3(ii) Exercise of Option: The words "deputationists who have joined Chandigarh Administration after 31.03.2022 may be asked to exercise option as applicable" may be read as "the government employees on deputation with Chandigarh Administration Irrespective of date of joining, may elect to draw either the pay in the Level/Scale of Pay of deputation post or his/her basic pay in the parent cadre w.e.f. 01.04.2022 in terms of Para 4 of the DoPT's O.M. dated 28.03.2024 ibid as applicable."

Para 3(iii) Deputation (Duty) Allowance:- In terms of para 8.3.2 of DoPT's O.M. dated 28.03.2024 ibid, Deputation (Duty) Allowance would only be admissible upto fifth year as calculated from the date of joining or 01.04.2022, whichever is later. Once the officers/ officials exercise their option to draw pay of his/her parent cadre, the grant of Deputation (Duty) Allowance, after reviewing deputation terms, may be regulated in terms of provisions of the Govt. of India, DoPT's O.M. dated 28.03.2024. However, consultation of Finance Department may be sought, if required.

- Para 3(iv) Dearness Allowance:- The deputationists opting to draw pay of the post against which they have been appointed on deputation shall be entitled to Dearness Allowance at the rates applicable in Chandigarh Administration. However, in such cases, pay of the deputationists will be re-fixed as per guidelines of the Govt. of India, DoPT's O.M. dated 28.03.2024 and Dearness Allowance as per Govt. of India's orders as issued from time to time. In the case of deputationist who opt to draw the pay of his/her parent cadre post, a separate proposal may be furnished to the Finance Department for consideration as they shall be eligible for Dearness Allowance at the rates prevailing in their parent organization (i.e. the lending State or Central Government).
- This issues with the concurrence of Finance Department conveyed vide U.O. No. 7000/1/3-F&PO(7)/2025/7404 dated 15.05.2025.
- 3. The contents of this communication may kindly be brought to the notice of all the concerned officers/officials working under your control for information and necessary action.

Standard Terms and Condition of the Government employees on deputation with Chandigarh Administration

Sir/Madam

I am directed to address you on the subject noted above and to state that the Ministry of Home Affairs, Government of India, in terms of notification No. GSR 230 (E) dated 29.03.2022 (issued by the Government of India, Ministry of Home Affairs, New Delhi) has vide letter No. U-13034/56/2022-CPD dated 06.03.2025 (copy enclosed), revised the terms and conditions of Government employees on deputation with Chandigarh Administration. It has been stated that the Union Territory of Chandigarh Employees (Conditions of Service) Rules, 2022 have been made applicable to the employees under UT of Chandigarh Administration w.e.f. 01.04.2022. Accordingly, Department of Personnel & Training, Govt. of India's notification dated 08.09.2022 on Regulation of terms and conditions governing deputation/ foreign service of employees to/from Central Government is applicable to the Government employees on deputation with Chandigarh Administration.

The Govt. of India, DoPT has further issued consolidated guidelines on deputation/ foreign service vide O.M. No. DOPT-1726140763694 dated 28.03.2024.

In view of above, departments are requested to keep in view the provisions of revised deputation policy, some of which are mentioned below:-

- Applicability:- The cases of the employees mentioned under Para 2.2 of (i) the O.M. dated 28.03.2024 ibid are governed by separate set of instructions/ guidelines and such employees are not covered by provisions contained in the said O.M. dated 28.03.2024.
- Exercise of Option:- As per para 4.1 of the O.M. dated 28.03.2024, "an (ii) employee appointed on deputation/foreign service, may elect to draw either the pay in the Level (in the Pay Matrix)/Scale of Pay of deputation/ foreign service post or his/her basic pay in the parent cadre plus Deputation (Duty) Allowance thereon plus Personal Pay, if any." Para 4.2 & 4.3 provide that the borrowing authority shall obtain the option of the employee within one month from the date of joining and option once exercised shall be final. Accordingly, deputationists who have joined Chandigarh Administration after 31.03.2022 may be asked to exercise option as applicable.
- Deputation (Duty) Allowance: Para 6.1 of the O.M. ibid mentions the (iii) rates of Deputation (Duty) Allowance admissible to the employee appointed on deputation.
- Dearness Allowance:- As per para 7.6 (c)(i) of the O.M. ibid, "the (iv) employees shall be entitled to dearness allowance at the rates prevailing in the borrowing organization or in the lending organisation depending on whether he has opted to draw pay of the ex-cadre post or the parent cadre post".

- Tenure of Deputation/Foreign Service:- As per existing standard terms and conditions of deputation as circulated by this department vide letter dated 12.03.1996, the period of deputation had been "one year in (v) the first instance and to be extended from time to time". However, in terms of Para 8.1 of the O.M. ibid, "the period of deputation/foreign service shall be as per provisions of the RRs of the ex-cadre post or 5 years in case no tenure regulations exist for the ex-cadre post." Para 8.3.1 (iii) of the said O.M. provides that "no further extension beyond 7th year shall be granted".
- Repatriation may accordingly be planned on First In First Out basis. All departments are advised to take up the matter well in advance with the lending organisations to send replacements so as to comply with Para 8 of the O.M. dated 28.03.2024 as amended from time to time.
- In case of any doubt, instructions issued by the Government of India, Department of Personnel & Training, New Delhi vide O.M. dated 28.03.2024 as amended from time to time may be referred.
- The contents of this communication may kindly be brought to the notice of all the concerned officers/officials working under your control for information, necessary action and strict compliance.
